The Homicide Bereavement Program at Wayside serves children and adults, ages 5 years and older, in Middlesex, Norfolk, and Worcester counties, who have experienced the effects of murder or vehicular homicide. Free services include individual and group counseling, court advocacy, and extended supports to family and friends of homicide victims. The program also seeks to support other community providers who must deal with the effects of homicide. By having strong outreach, the program assists those people and providers with their vicarious trauma from murder.

### *Child Witness to Violence:*

The Child Witness to Violence Program at Wayside serves clients 5 years and older along with their non-offending significant others in Middlesex, Norfolk and Worcester counties, who have witnessed or experienced domestic violence, dating abuse, bullying, and other forms of violence. Free services include counseling or advocacy in individual and group formats, along with crisis intervention at the host agency, schools, courts, and in the community. There is an ongoing Domestic Violence support group for women weekly. Referrals and resources are tailored to the individual client and provided as needed.
